Zia BOD/Annual Meeting Minutes, January 13, 2022

The January 13, 2022 BOD Annual meeting began at 7:00 p.m. at the Sheraton Uptown Hotel, with President Charles Moots presiding. Ron Bjornberg reported that 83 Zia members and 7 guests attended the meeting. A quorum of the BOD was achieved, 14/22 BOD members attending.

<u>Item I -</u> The minutes of December 16, 2021 BOD meeting was approved with no changes. The January 13 meeting agenda was approved with no additions. Treasurer Jack Cleary presented the Treasurer's report and reported on the very healthy financial status of Zia.

Item II-Legislative issues Amanda Sanders, our NRA-ILA representative for the Grassroots Program, reminded us to hold our New Mexico law makers accountable for any new anti-gun laws put forward and ask them why they are supporting any particular anti-gun bill. Zac Fort, President of the New Mexico Shooting Sports Association (NMSSA) expressed the NMSSA concerns about New Mexico's upcoming anti-gun legislation and encouraged us to contact our state representatives to oppose this legislation; he requested that we visit the NMSSA web site to keep up to date on the latest anti-gun legislation being proposed in the current legislative session and asked that we contact our respective state representatives to express our concerns.

Item III-Old Business- There was no membership quorum to support election of the Zia BOD or address business issues. President Charles Moots reported on business matters for the annual meeting: there were no By-Law changes or dues changes proposed. President Moots announced that he would be stepping down as the President of the Zia Rifle and Pistol club in the May or June time frame and introduced Pat Mileshosky, second Zia BOD Vice President as his replacement given Zia BOD approval. Pat Mileshosky addressed the audience, thanking President Charles Moots for all he has done for the club and that he would do his best for the Zia Rifle and Pistol Club. The BOD Ballot for Zia members running for Zia BOD positions will be published in the February and March newsletters for mail-in voting by the general membership in order to complete the BOD election. The results will be tabulated at the March BOD meeting and results published in the April Newsletter. Membership Renewal Application for the membership year April 1, 2022 - March 31, 2023 has begun, with application information in the January Zia News Letter. Applications received after April 30, 2022 will be charged a late fee of \$35 and after May 1, 2022 keys will be deactivated for those who have not renewed their membership.

Item IV-New Business- After adjournment of the BOD Meeting, Ron Bjornberg officiated in presenting gift cards from Cabela's and Sportsman's Warehouse to all in attendance. 

Action Pistol and Practice Ranges.

6. _____ Do not use any magnum, Armor Piercing, or other ammo that will damage steel targets.

7. ____ Except for special events, Cased firearms are treated the same as Uncased firearms with regard to handling during "Cold Range" periods.

8. _____ The Small bore Silhouette, Bulls-eye Pistol, and Bench rest Ranges are considered as one for Range Officer control.

9. _____ You may use your own targets on your own frames or target panels provided. Do not attach targets to target frames, cross members, steel gongs or hangers.

10. _____ Legally registered class III and bump-fire weapons are limited to the western practice (plinking) ranges.

10a. DO NOT USE SHOTGUNS on OR DESTROY THE ZIA TARGET FRAMES!

11. _____ The practice ranges are the only berms where other than standard paper or steel targets are permitted.

12, _____ Each Action Pistol range is considered separate for Range Officer control.

13. _____ Steel Targets are not permitted on the eastern-most Action Pistol range.

14. _____ The Tunnel Range hatch cover is not a target stand. It serves as a gate when firing is in progress.

15. _____ Turn out lights, turn off the fan, clean up the area and secure all doors before leaving the tunnel range.

16. _____ On the Shotgun Range, fire only in the direction of west to south between the white posts. 16a. ____ The area west and the area South of the main Shotgun Range is closed except for Specific Activity functions.

17. _____ The Shotgun Range is considered separate from the High Power and Metallic Silhouette Ranges and does not require the flag to be raised.

18. _____ On the Shotgun Range do not use shot larger than #7.5.

19. _____ It is OK to leave clay bird launchers in a cocked condition when you leave the Shotgun Range.

20.____ There is no need to pick up spent shells when shooting is complete on the Shotgun Range.

21. _____ The High Power and Metallic Silhouette ranges are considered as one for Range Officer control and the area between the Metallic Silhouette range and the east fence is for activity use only.
22. _____ Before using either the High Power or Metallic ranges, and the flag is already raised, and no one is evident, you must physically inspect the ranges before beginning shooting activity.

23. ____ Do not mount targets on the T-stands or gong hangers on the Metallic Silhouette Range.

24. _____ The first shooter on a range is the acting Range Officer for that range.

25. _____ You may pack up your equipment and firearms during a cease fire.

26. _____ Memberships expire on April 1 of each year. Keys may be de-activated at anytime after that date.

27. _____ There is no penalty for mistakenly calling a cease-fire.

28. _____ Law enforcement officers not on official business and those with carry permits may carry loaded firearms on Zia.

29. _____ Place your targets in front of the berms, not on top of the berms.

30. _____ You may handle, load and fire your weapon(s) (including cased weapons) only after the Range Officer has called the range "Hot".

31. _____The patterning board on the shotgun range may only be used at a distance of 20 yards or more and only with size 7.5 shot or smaller.

32. <u>Magnum calibers, armor piercing rounds and other enhanced penetration designs may not</u> be fired at steel targets.

33. _____ You must case or bag your loaded firearm before bringing it to a "hot" firing line.

34. _____ Incendiary, exploding and /or tracer ammunition is strictly prohibited on all Zia Ranges due to extreme fire danger.

35. _____ Any individual member may be suspended or expelled for conduct contrary to or in violation of, the By-Laws of the Club, or the Club Range Safety Regulations and rules of Conduct, false or misleading statements to obtain membership, or other reason(s) deemed sufficient by the club. (By-Laws).

36.____ Members are expected to pick up their own trash, used targets, spent cases, etc. and place them in the receptacles provided.

37.____ Members are expected to conduct themselves in a manner that promotes a safe and friendly environment. Foul language, displays of anger and unsportsmanlike conduct could be grounds for a member being suspended or expelled from Zia.

38. _____ Any reported safety violation will result in appearance before the Board of Directors (BOD) and repetition of the range safety course as a minimum.

39. _____ Members of all categories are responsible for knowing the contents of the Range Safety Regulations and Rules of Conduct and complying therewith.

40. _____ The Board of Directors meetings are open to all club members.

41. _____ Any member present may be given the floor at BOD meetings and be heard at the discretion of the Chairperson, but only members of the Board have a vote in the proceedings.

42. _____ If you have a membership issue such as Key Card not operating, lost Key Card, not receiving the Newsletter, phone #, name, etc., contact printprof@aol.com.

43. _____ If you want to donate an extra \$35 for your annual membership, wait until after April 30 of each year to send in your renewal application, etc..

44. _____ "For Profit" training can only be conducted by NRA certified instructors on Zia property.

45. _____ Zia is a "cold Range". This means no one may handle, carry, load or fire weapons in any way on Zia property unless you are on a designated firing line and it is called "Hot" by the acting RO (Includes Cased Weapons).

46. _____ It is OK to ignore the "Closed to other than Formal Activity Events" signs on the any range because a "first safety violation" is just a warning and your key card won't be deactivated until you visit the Board of Directors meeting. (Refer to question 35, 38, 39)
