### **Zia BOD Meeting Minutes from August 18, 2022**

The August 18, 2022 BOD meeting was called to order at 7:02 p.m. at the Bear Canyon Senior Center, with club President Pat Mileshosky presiding. A quorum of the BOD was achieved with 14 of 20 BOD members in attendance.

### Item I - Approval of Agenda and Minutes

The agenda for the August 18, 2022 meeting was approved with seven additions (update on ARA purchase, shotgun trap carts, member at large vacancy, new rimfire steel activity, NRA grant, perspective members, and website revisions.)

The minutes for the July 21, 2022 BOD meeting was approved without changes.

#### **Item II - Treasurer's report**

Club Treasurer Gary Wells presented a report on the past month's flow in and out of the treasury and that our taxes have been filed.

#### **Item III - Old Business**

**Update on ARA equipment:** Jim Pollard, ARA Activity Chair reported a computer, scanner, printer, and table were purchased and in the hands of the activity's tech person. Targeting to have these ready for an upcoming tournament.

**Update on new website:** Pat Mileshosky, Club President reported that there has was some churn at the new web company, delaying the rollout of our new site. Our current hosting expired on 8/18/22, and Heidi is pushing to get the new site up inside of two weeks.

#### Item IV - New Business

**Membership and Orientation:** Peter Ide, MAL and Orientation Chair presented a detailed report. Highlights include: we still have people who do not respond to invitations (they go on a special list after 3 "no responds"), folks who apply are being invited to the next available class (effectively no waiting list), we oriented 126 members YTD, and currently have 1611 non-Junior members.

**Donation to the NMSSA:** Peter reported on shenanigans planned for the upcoming 60-day NM legislative session and suggested the Club support the NMSSA with a \$10k donation. A motion was made, seconded, and approved following a lot of great discussion.

**Rimfire Steel Activity:** Ted Simmons is developing a new rimfire steel activity designed to entice youth and family participation. Highlights include: first Saturday, simplified adaptation of <u>RCSA Rimfire Challenge</u> (25' pistol, 50' rifle), and requested \$1k to purchase equipment and supplies. A motion was made, seconded, and passed.

**Trap Carts:** Lyn Carter, Sporting Clays Chair showed photos of a prototype trap cart made by a member, described a plan to test and evaluate it, and requested \$514 to reimburse the maker for supplies. A motion was made, seconded, and passed.

**Members at Large:** Lyn presented Javier Chavez as a qualified member who is interested in the open MAL position. After some discussion is appears we may have multiple qualified members who want to serve the club in as MALs, and so decided to reevaluate them at the next BOD meeting.

**NRA Grant:** Heidi informed the BOD that a grant application was filed to obtain support for the ladies class. Last year no grants were awarded due to no fundraising by the Friends of the NRA.

Perspective Members: Heidi also laid out some procedures for people looking to join Zia while the web site is down.

**Nomination Committee:** Pat Mileshosky, President appointed Joel Baca as Chair of the 2023 Nomination Committee with members Lois Blanchard, Ted Simmons, and Heidi Chowning.

First place went to **John Benson** with 36! He shot 10 pigs, 5 chickens and 5 rams in a row!

There was a three way tie for 3<sup>rd</sup> place between **Dennis Barnhart**, **Sharon Foreman** and the newest addition to the group **Bob Guarnieri** all with 31...

After a shoot off at the 1/5 size pigs, **Dennis Barnhart** took 3<sup>rd</sup> place, followed by **Sharon Foreman** in 4<sup>th</sup>, and **Bob Guarnieri** placing 5<sup>th</sup>. **Dennis Barnhart** got 10 chickens and 5 pigs in a row. **Bill Sherman** got 5 chickens in a row and 5 rams in a row (this is the first time that Bill shot 5 rams in a row way to go Buddy!). The "new" shooter **Bob Guarnieri** got 10 chickens in a row. **Ted McTammany** got 5 chickens in a row.

Lucinda Sherman again shot with open sights and turned in a score of 16. This girl is on Fire!

<sup>2&</sup>lt;sup>nd</sup> place went to **Tom Foreman** who shot 32 with 5 chickens, pigs and rams in a row.

### 1/5 size target results:

There were no competitors for the 1/5 size target category. **David Barboza** and **Sid Gariss** were in Hobbs New Mexico competing in the State of New Mexico Small Bore Rifle Silhouette matches. David placed 3<sup>rd</sup> overall in the AA class. According to Sid, it just wasn't his day.

Although there we no 1/5 size competitors, we still had 4 full relays. Immediately following the match we had a pot luck lunch that included paella that was cooked fresh at the range by John Benson.

Small Bore Silhouette shooting is one of the most challenging sports for individual marksmanship. Many great shooting competitions offer challenging shots at long range from a bench or other supported position. All our shooting is done from a standing position swaying in whatever breeze there happens to be. We shoot 10 chickens at 40 meters, 10 pigs at 60 meters, 10 turkeys at 77 meters, and 10 rams at 100 meters. A total of 40 rounds are needed for a match plus sight in rounds.

We shoot with .22 rim fire rifles with scopes or open sights. Any standard velocity or high velocity .22 short, long, or long rifle ammo is permitted but the extra hot rounds such as the STINGER or VIPER rounds and magnums are prohibited.

The following in information taken from the NRA Silhouette Rifle Rule book and explains the match time sequencing:

Time is not checked on each shot but is computed on the indicated allowance for each five-shot string. The Range Officer may terminate any relay before completion of the full time allowance, if all competitors in that relay have completed firing.

#### Time Allowances:

Ready Time - Fifteen seconds will be allowed after the command **READY** is given before the command **FIRE**.

Two and one half minutes will be allowed to fire one shot on each target of a bank of five targets. Targets are shot in sequential order from left to right.

Alibis - 30 seconds will be allowed for each unfired round of the series in which the alibi is allowed.

**Shoot-offs** - 30 seconds will be allowed for each shot fired in a shoot off of ties.

A minimum of 30 seconds will be allowed between the command CEASE FIRE and READY.

Setup starts at 8:00am. We will have a sight in/practice period starting after set up and will start the match promptly at 9:00am. This event is open to any Zia member/guest and all are welcome. Juniors are encouraged to try this fun and challenging shooting sport.

The small bore rifle silhouette match is held on the first Sunday of each month. **The next match will be on October 2nd.** I hope you can make it!

The adjacent bench rest/plinking range to the immediate West of the Small Bore Rifle Silhouette Range will be closed for the duration of our matches. This will allow us to provide participants with a higher level of safety.

Please note: Although the posted sign states that the range will be closed from 8:00am 2:00pm, as soon as the small bore rifle silhouette match is over, the adjacent range will be open to the public. Historically our matches run no later than noon.

There was excellent weather and almost no activity in the wind flags. 8 shooters were present for a full relay, so we got done rather quickly

John Robison had the highest score with 33 followed by Gary Devlin with 30. Then a couple of 29s and on down the line to an unusual low of 8 points. We all have our days! Long range bench rest silhouette is very challenging at best, particularly when shooting a .22 rimfire rifle from 60 to 200 meters; even the slightest breeze can wreak havoc.

The bench rest rifle silhouette (formerly known as "Mouse Gun") match is held on the second Sunday of each month. This coming month (October) the match will be on October 9<sup>th</sup>.

For those of you that are wondering what we do...

We take a scoped .22 rifle that has plenty of elevation adjustment and shoots long rifle ammo (**no stingers or hyper velocity**) and we shoot at 1/5 scale targets, whereas the chickens are set a 60 meters and are roughly 2"x2" in size. The pigs which are roughly 3"x4" are set at 100 meters, the turkeys, roughly 3"x5" tall are set at 150, and the rams 6"x4" are at 200 meters. All you need is a sand bag, maybe a bipod, or perhaps a fancy bench rest rig, it doesn't matter as any type of rest is allowed. At the onset of each 15 minute relay, there are unlimited "sighters" at the beginning sighters being shots that are fired at a 8"x11" steel plate set at the same distance at each of the targets. When you are pretty sure that your rifle is sighted in good enough for that bay of targets, the "sighters" stop and you shoot 10 shots in left to right order in what is remaining of the 15 minute time allotment for score.

Relays consist of 10 chickens at 60 meters, 10 pigs at 100 meters, 10 turkeys at 150 meters, and 10 rams at 200 meters. This all done while sitting at a bench. It is a relaxed atmosphere and a ton of fun! A total of 40 rounds are needed for a match plus "sighters".

Setup starts at 7:30 am. We will have a sight in/practice period starting after set up if possible, and will start the match promptly at 8:00am.



### Mandatory Gun Storage Proposals Protect Criminals & Leave Law-Abiding Citizens Vunerable

New Mexico already has a law on the books to hold adults accountable for endangering a child. (NMSA Section 30-6-1, New Mexico's Child Abuse/Abandonment statute). Under the law, it is a felony for a responsible person to knowingly, intentionally, or negligently, and without justifiable cause, cause or permit a child to be placed in a situation that may endanger the child's life or health. Prosecutors have the tools, in appropriate cases, to hold parents, guardians or other custodians of children accountable when a child gains unauthorized access to any dangerous or illegal substance or weapon and harms himself or someone else.

Mandatory gun storage laws are also ineffective. According to a study by John R. Lott, Jr., PhD, and John Whitley, "Safe Storage Gun Laws: Accidental Deaths, Suicides, and Crime," - there is no evidence that CAP laws reduce either juvenile accidental firearm deaths or suicides. Instead, these laws appear to make it harder for law-abiding gun owners to protect themselves. Out of ten states studied that had CAP laws for at least four years, relative violent crime stopped falling when these statutes were adopted and then ended up even higher at the end the four-year period. The only consistent impact was that these laws were significantly related to higher rates of rape, robbery, and burglary.

Lastly, this type of legislation will have a chilling effect on youth participation in firearm-related activities and it may be unconstitutional. Language in these laws set potential legal traps for responsible parents whose children participate in legitimate recreational, training and competitive activities. Additionally, the United States Supreme Court struck down as invalid laws that require "firearms in the home be rendered and kept inoperable at all times." (District of Columbia v. Heller, 2008.) The Court affirmed that "the need for defense of self, family, and property is most acute" in the home and the Second Amendment "elevates above all other interests" the right "to use arms in defense of hearth and home." (Heller) Clearly, a firearm meant for home defense must be accessible and operable.

#### Unconstitutional Restrictions on Firearms Sales to Young Adults Won't Reduce Crime

At age 18, citizens are eligible to vote, serve in the military (83% of United States Marine Corps enlistees are 20 or younger) and be drafted. An 18-to-20-year-old may be tried as an adult for crimes in state and federal courts. Young adults may serve in law enforcement, may generally serve on a jury, enter into contracts, sue and be sued, get married and own property. The landmark SCOTUS *District of Columbia v. Heller (2008)* decision did not suggest that young adults are excluded from "the people" protected by the Second Amendment. As the *Heller* decision made clear, "the people, from whom the militia must be taken, shall have the right to keep and bear arms." At the time of the Founding, 18-to-20-year-olds were permittedindeed required to be part of the militia and to arm themselves. The age of majority remains 18 today for militia.

In NYSRPA v. Bruen (2022), SCOTUS made clear that in order for a firearm regulation to pass muster under the Second Amendment the government must "identify a well-established and representative historical analogue." Regarding prohibitions on young adults purchasing firearms, this cannot be done. There were no laws that restricted 18-20 year-olds from purchasing firearms at the time of the American founding.

Following the Bruen decision, a federal court in Texas struck down the state's prohibition on 18-20-year-olds carrying a handgun outside the home for self-defense. The decision pointed out that "Heller said that 'the people' is a term of art that refers to 'all members of the political community, not an unspecified subset." Moreover, noting Bruen, the decision explained, "Bruen said it was undisputed that "ordinary, law-abiding, adult citizens are part of 'the people' whom the Second Amendment protects." Given the precedent in these two cases, the federal court stated the following,

With this guidance, the Court asks a simple question: are law-abiding 18-to-20-year-olds properly considered members of the political community and a part of the national community? The answer is yes. And based on that answer, the Court concludes that law-abiding 18-to-20-year-olds are a part of "the people" referenced in the Second Amendment.

Only 7 states restrict the purchase of long guns by 18-20 year-olds: CA, FL, HI, IL, NY, VT & WA. Litigation is on-going on these bans. In May, a panel of the 9th U.S. Circuit Court of Appeals ruled that a California law banning the sale of semi-automatic centerfire rifles to adults under 21 was unconstitutional (*Jones v. Bonta*). In March, a panel of the 11th U.S. Circuit Court of Appeals heard arguments on the Florida law prohibiting the sale of rifles and shotguns by licensed dealers to adults under age 21. NRA is a plaintiff in this lawsuit (*NRA v. Swearingen*).

Making further state action unnecessary, the federal government has instituted a 3-10 day federal waiting period for 18-20-year-olds purchasing firearms. During this period, the FBI is tasked with conducting a so-called "enhanced" background check on the prospective purchaser. This includes an examination of state juvenile records and contacting local law enforcement in the jurisdiction in which the purchaser resides.

In 2019, Dr. Gary Kleck published the research paper "Regulating Guns Among Young Adults" in the American Journal of Criminal Justice. This study assessed the impact of state bans on gun carrying among persons age 18 to 20 on rates of murder, robbery and aggravated assault. The results indicated no significant effect of these bans on any of the three violent crime rates. A second study assessed the impact of the federal ban on the purchase of handguns by persons aged 18 to 20. Results indicated there was no impact on the 18 to 20-year-old share of arrests for homicide, robbery, or aggravated assault. https://link.springer.com/journal/12103/volumes-and-issues/44-5

### Magazine Limits and Semi-Automatic Firearms Bans: Failed Gun Control Studied, NotRenewed by Congress

Gun control advocates falsely use the term "high capacity magazines" to describe standard equipment rather than magazines which stretch a firearm's capability beyond its intended design. They also use the term "assault weapons" to describe commonly-owned semi- (not fully-) automatic modern sporting rifles used for recreational and competitive shooting, hunting and protection. Magazines are manufactured as standard equipment for handguns and rifles that often accommodate 15 to 30 rounds of ammunition. There are roughly 304 million detachable magazines and almost 80 million of these can accommodate more than 30 rounds. There are approximately 20 million AR-style semiautomatic rifles in circulation in the U.S.

Under the expired federal "Assault Weapons" Ban between 1994-2004, the production of newly manufactured magazines for both rifles and handguns was limited to a capacity of 10 cartridges. A 1997 Department of Justice-funded study of the Clinton ban determined that "At best, the assault weapons ban can have only a limited effect on total gun murders, because the banned weapons and magazines were never involved in more than a modest fraction of all gun murders." A 2004 follow-up Department of Justice-funded study came to a similar conclusion. The study determined that "AWs [assault weapons] and LCMs [large capacity magazines] were used in only a minority of gun crimes prior to the 1994 federal ban," "relatively few attacks involve more than 10 shots fired," and "the ban's effects on gun violence are likely to be small at best and perhaps too small for reliable measurement." Presented with the overwhelming evidence of the ban's inefficacy, Congress did not renew it.

A recent survey of available research (2020) by the RAND Corporation found there is no conclusive evidence for the effect of high-capacity magazine and assault weapons bans on firearm homicides. <a href="https://www.rand.org/research/gun-policy/analysis/ban-assault-weapons/mass-shootings.html">https://www.rand.org/research/gun-policy/analysis/ban-assault-weapons/mass-shootings.html</a>. In 2013, Colorado enacted a law banning magazines that hold more than 15 rounds. While the state experienced a slight decrease in total firearm-related murders (-4 total) from 2013 (106) to 2014 (102), it then saw a 35-murder increase (to 137 total) in 2015 and the number continued to rise: to 161 in 2016, 160 in 2017, 188 in 2018, 164 in 2019, 206 in 2020.

Prohibitions on commonly-owned semi-automatic firearms and their magazines violate the Second Amendment. In *Heller*, SCOTUS made clear that that the types of firearms protected by the Second Amendment include those "in common use at the time" for "lawful purposes like self-defense." The AR-15, which is the favorite target of so-called "assault weapon" ban legislation, is the most popular rifle in America and therefore undoubtedly "in common use" and protected by the Second Amendment. In 2015, *Heller* decision author Justice Antonin Scalia joined Justice Clarence Thomas in a dissent from the denial of certiorari in a case concerning a local ban on commonly-owned semi-automatic firearms. The document made explained,

Roughly five million Americans own AR-style semiautomatic rifles. The overwhelming majority of citizens who own and use such rifles do so for lawful purposes, including self-defense and target shooting. Under our precedents, that is all that is needed for citizens to have a right under the Second Amendment to keep such weapons.

In *Bruen*, the Court reiterated its holding that the "Second Amendment protects the possession and use of weapons that are 'in common use at the time." In addition to reiterating *Heller*'s holding protecting firearms "in common use," which precludes the prohibition of commonly-owned semi-automatic firearms and their magazines, Bruen made clear that in order for a firearm regulation to be valid under the Second Amendment the government must "identify a well-established and representative historical analogue." As there is no historical tradition of banning these items in the U.S., such a prohibition would be precluded by this standard as well.
